**Final Payments due to Therapy Abroad:** 60 days prior to departure

**Cancellation Prior to Departure:** \$250 non-refundable deposit due

**89-60 days Prior to Departure:** 75% refund of Therapy Abroad Program Fee

**59-30 days Prior to Departure:** 50% refund of Therapy Abroad Program Fee

**30 Days Prior to Departure or Later:** 100% of the total Therapy Abroad Program Fee is owed, no refunds available
