**Instituto Nebrija Withdrawal Policy:** Registration fee and tuition deposit are non-refundable. All other payments (remaining of the tuition-except the deposit-, housing and excursions) will be refundable only if there is notification of the cancellation in writing and at least four weeks in advance. If notification is given less than four weeks in advance, the student will be refunded 25% less the amount corresponding to the tuition for each week of delay in the notification. Once the program has started, refunds will not be provided.
