LDM Tuition Cancellation Policy:

- 45-31 days prior to the beginning of the term, the student will be liable for \$500 tuition.
- 30-0 days prior to the beginning of the term, the student will be liable for half of the tuition cost.
- Withdrawals after the start of the program, liability amounts to full tuition and no refund will be made by LdM.
- The student will be fully liable for the total tuition cost if no official notice of the student's cancellation is received before the start of the program.

LDM Housing Cancellation Policy:

- 45 days or MORE prior to the check-in date, the \$300 security deposit and full rent payment will be refunded.
- 44-31 days preceding the check-in date, the student will lose the security deposit (US\$300) but will be refunded the full rent payment.
- 30-11 days preceding the check-in date, the student will lose the security deposit (US\$300) and part of rent payment
- 10-0 days preceding the check-in date – or fails to check-in to his or her housing assignment – the student is responsible for the full rental amount of the accommodation for the entire academic term.

Students who stay for BOTH summer sessions will receive housing at no extra cost during the break between the two summer sessions
